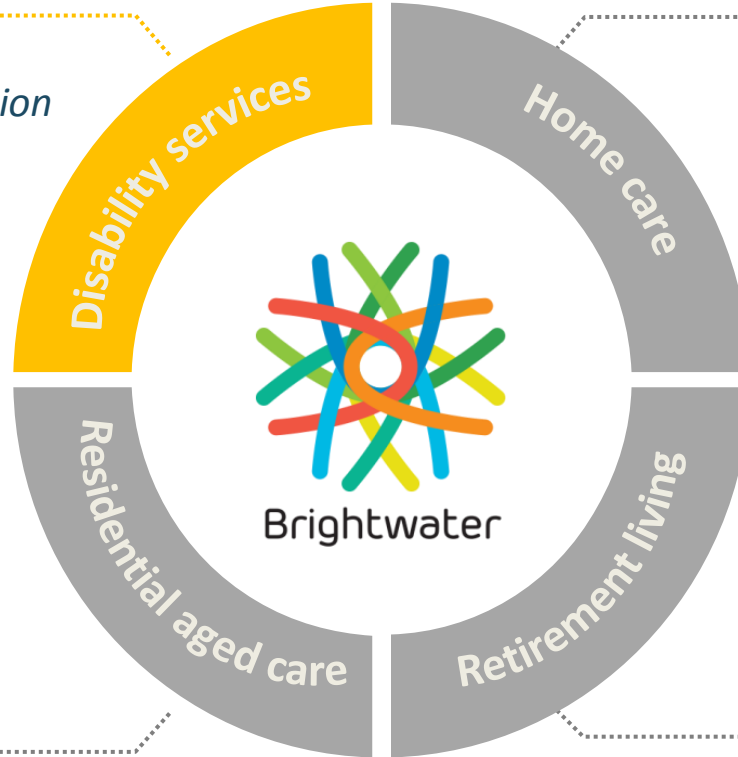
# Brightwater services

# NDIS Overview

- NDIS will be available across the State – 1 July 2019
- Administered by the National Disability Insurance Agency (NDIA)
- The NDIS is the new way to providing disability support for people with disability to get the care and support they need
- Funding can be used to support participation in education, employment, community, independent living, health and wellbeing

# NDIS Eligibility

To become an NDIS participant a person must:

- Have a permanent disability that significantly affects their ability to take part in everyday activities
- Be aged less than 65 years old
- Be an Australian citizen or hold a permanent visa or a Protected Special Category visa
- Live in Australia where the NDIS is available



# NDIS – reasonable and necessary funded supports

- Must support participant's goals and be related to the disability
- Must not include day-to-day living costs **not** related to the disability support needs
- Should represent value for money
- Must be likely to be effective and work for the participant
- Should take into account support given by other government services, family, carers, networks and the community

# NDIS Health Interface

The health and disability sector are working together to:

- Develop an understanding of the NDIS
- Support NDIS access requests, plans and reviews
- Provide supporting evidence i.e. functional assessment reports
- Adapt discharge planning and referral pathways, including links with community services

# NDIS Evidence and Language

- The NDIA needs to be able to quickly identify key information, evidence and recommendations to assist their decisions.
- All reports/letters should be written in plain language
- Detail the functional impact, not just the diagnosis
- Categorical statements about ‘permanent disability’ can be difficult

# Evidence and language

- Evidence the impact on quality of life, safety and preventing further decline.
- Highlight absence of informal supports where appropriate e.g. family and carers.
- Use the 'right' language:
  - permanent, long term functional impact
  - limited ability to achieve functional goals
  - barriers to economic/social participation

Note: NDIA will not fund recurring health or medical conditions
